## DRUG RESIDUE POLICY

### CERTIFICATE OF ANIMAL MEDICATION

PLEASE READ CAREFULLY AND SIGN.  
(LIVESTOCK WILL NOT BE SOLD IF NOT SIGNED.)

Every market animal exhibitor at the San Joaquin County Fair must complete this form before sale of animal at the Junior Livestock Auction. Animal will not be eligible to sale if form is not signed and delivered to the Livestock Office.

**UNDER PENALTY OF PERJURY, WE THE UNDERSIGNED CERTIFY THAT:**

A) NO UNAUTHORIZED CHEMICALS HAVE BEEN USED WHICH WOULD CAUSE THE CARCASS OR ANIMAL TO FAIL USDA AND FOOD & DRUG ADMINISTRATION STANDARDS.

B) THE WITHDRAWAL TIME REQUIRED OF ANY MEDICATION (INCLUDING MEDICATED FEED) HAS BEEN ADHERED TO.

C) Owner is responsible for the animals rejected at processing center due to the presence of drug residues.

D) Owner will report to management and any and all drugs or medications administered to an animal that might still be detected at the time of showing. The name of the drug, dosage, its purpose, time and date of administration will be required. This must be done before showing the animal.

E) Owner is responsible for any fees that arise from the processor caring for the animal while waiting the specified time to process after the use of drugs. If the processor refuses care of the animal, for the time specified for the drug used, the Owner may care for the animal and make the appropriate arrangements with the buyer and the processor.

AS THE OWNER of this market animal, I acknowledge I will be responsible for my animal if it is rejected at a processing center due to the presence of Drug Residues. If Drug Residue is detected I may be liable to the buyer for an amount equal to THREE TIMES the purchase price and may be liable for attorneys' fees and civil penalties (Food & Agriculture Code Section 14363)

## CODE OF PRACTICE

I wish for my livestock project to be an example of how to accept what life has to offer - good and bad - and how to live with the outcome.

- the production of wholesome food,
- and the development of sound moral character in myself - and others.
